#### ARTICLES OF INCORPORATION

The undersigned incorporator, WILLIAM R. MCKELVY, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

#### **ARTICLE I - NAME**

The name of this corporation is NAVARRE 33, INC.

#### **ARTICLE II - PRINCIPAL OFFICE**
