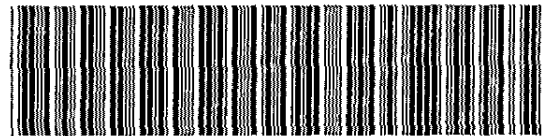

**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this Corporation is Rick Gunter Mobile Servies, Inc. and the physical address is 35416 South Grays Airport Road, Fruitland Park, Florida 34731.

ARTICLE II - TERM OF EXISTENCE

The existence of this Corporation shall exist perpetually.

ARTICLE III - NATURE OF BUSINESS

This Corporation may engage or transact in any or all activities or businesses permitted in the laws of the United States of America and the State of Florida.

ARTICLE IV - CAPITAL STOCK
