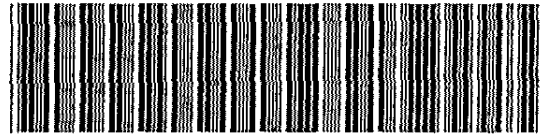

ARTICLE I
CORPORATE NAME, PRINCIPAL OFFICE
AND MAILING ADDRESS

ARTICLE II
NATURE OF BUSINESS AND POWER

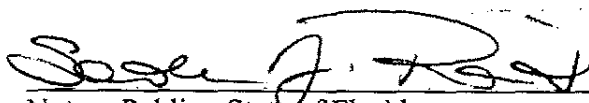

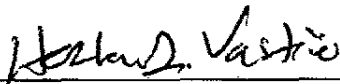
