The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

#### **ARTICLE I**

The name of this corporation is BILL MARTIN RENOVATIONS, INC.

#### **ARTICLE II**

The period of its duration is perpetual.
