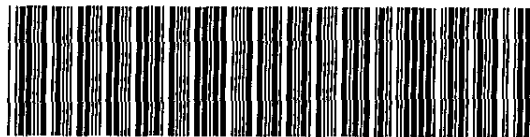


Article VII – Indemnification


