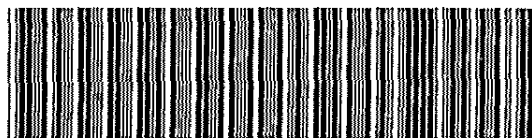

ARTICLE I—NAME

The name of this corporation is **50 ARTS ENTERPRISES, INC.**
