Pursuant to the Florida Business Corporation Act, these Articles of Incorporation provide that:

I. NAME

The name of the Corporation shall be:

II. COMMENCEMENT OF EXISTENCE

Corporate existence shall commence as of the filing of these articles.


VIII INCORPORATOR




