The undersigned subscriber to these Articles of Incorporation hereby forms the corporation under the laws of the State of Florida, as follows:

FIRST: The name of said corporation shall be ROMINA CORP., a Florida Corporation. The mailing address and the street address of the principal office of the corporation shall be: 18671 Collins Avenue, #2803, Sunny Isles, Florida 33125.

SECOND: ROMINA CORP., a Florida Corporation, shall have a perpetual duration from the date of filing of these Articles of Incorporation.

THIRD: The sole purpose for which ROMINA CORP., a Florida Corporation, is formed is:


