#### ARTICLE I. NAME

The name of the corporation shall be BERNSONGS MUSIC, INC.

#### ARTICLE II. TERM OF EXISTENCE

The corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation.

#### ARTICLE III. PURPOSE
