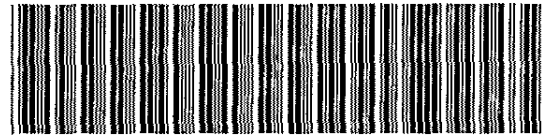


ARTICLE VII. INDEMNIFICATION


