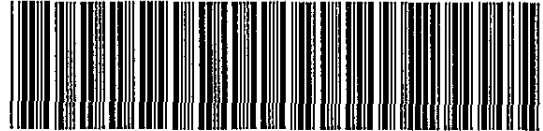

**ARTICLE OF INCORPORATION
OF
PERFECT DRIVEWAYS AND POOL DECKS, INC.**

ARTICLE ONE

The name of the corporation is **PERFECT DRIVEWAYS AND POOL DECKS, INC.** The principal address of the corporation is: 3508 NW 37th Avenue, Lauderdale Lakes, Florida 33309.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida Corporation Act.
