The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, adopt the following articles of incorporation:

#### ARTICLE ONE Name

The name of the corporation is: TERRY P. DECKER, INC.

## ARTICLE TWO Principal Office

The street address of the initial principal office of the corporation is 10517 Front Beach Road, Unit #1301, Panama City Beach, FL 32407.

## ARTICLE THREE Corporate Duration

The duration of the corporation is perpetual.

#### ARTICLE FOUR Purpose or Purposes

The general purposes for which the corporation is organized are:

- 1. To provide construction services.
- 2. To engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.

This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.
