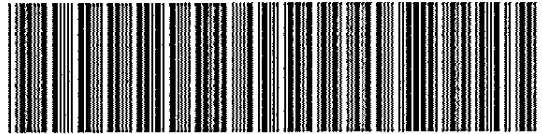

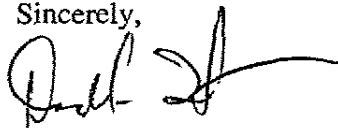

The undersigned subscriber to these Articles of Incorporation, being a natural person competent to contract, does hereby for a corporation under the laws of the State of Florida, for the purpose of becoming a Professional Service Corporation, pursuant to Chapter 621 and Chapter 607, *Florida Statutes* (2001) under and pursuant to the following Articles:

ARTICLE I

The name of this Corporation is:

ARTICLE II

The nature of the business of this corporation is to engage in the practice of Accounting Software Consulting & Installation and any and all lawful business which a corporation is permitted to conduct in the State of Florida.

ARTICLE III

The capital stock of this corporation shall be 100 shares of \$1.00 par value common stock. Said stock shall be issued pursuant to a plan under Section 1244 of the Internal Revenue Code of 1954 as amended by the Small Business Tax Revision Act of 1958.

ARTICLE X

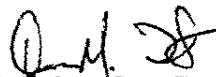

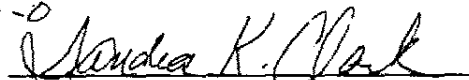

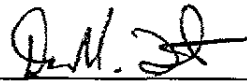
