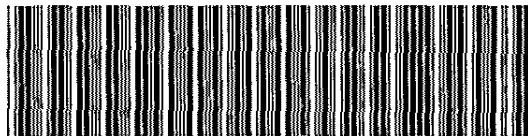

SECOND: Articles of Correction were filed on April 29, 2005 correcting the name of the Corporation.

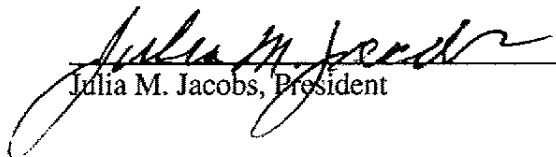

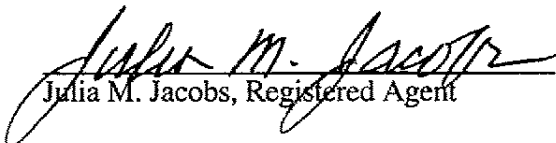
