ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF CORNERSTONE BUILDERS OF SW FLORIDA INC.

MILLIAR L'S PH I: 7

Pursuant to the provision of Sections 607.1003 through 607.1005 of the Florida Business Corporation Act, the undersigned corporation, CORNERSTONE BUILDERS OF SW FLORIDA INC., amends the Articles of Incorporation of the corporation originally filed with the Secretary of State of Florida on April 19, 2005, as follows:

1. Article IV is hereby amended to read as follows:

ARTICLE IV SHARES

The aggregate number of common shares the corporation shall have authority to issue shall be 10,000 shares of common stock, divided into voting and non-voting shares. The designation of each and the number of authorized shares of each are as follows:

Voting	2,500
Non-voting	7,500

All or any part of the shares of any stock may be issued by the corporation from time to time and for such consideration as may be determined upon and fixed by the directors, as provided by law; and when such consideration has been received by the corporation, such shares shall be deemed fully paid.

The nature and extent of the rights of the holders of the respective stock are as follows:

a. The Voting common shares shall have exclusive voting power, except as provided in c, below.

b. The Non-voting common shares shall have no voting power, except as provided in c, below.

c. The holders of the Non-voting common shares shall only be entitled to vote on such other matters as may be required by law to be submitted to such holders.

2. The foregoing amendment shall become effective and the Articles of Incorporation shall be deemed to be amended thereby upon the filing of these Articles of Amendment by the Department of State.
