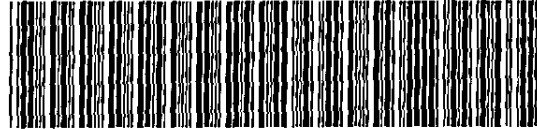

ARTICLES OF INCORPORATION
OF
ALL STATE STORM STOPPERS, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is ALL STATE STORM STOPPERS, INC.

ARTICLE II

The existence of the Corporation shall begin on April 12, 2005.

ARTICLE III

The street address of the principal office of the Corporation is 4248 Magnolia Ave, Leesburg, FL 34748.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 1,000, par value \$.01 per share, all of which shall be Common Shares.
