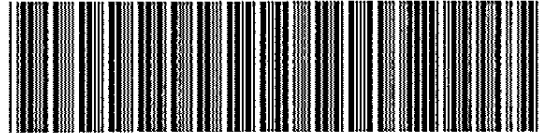

ARTICLE I
Name

The name of the corporation is **STEPHEN C. MAYS, P.A.**

ARTICLE II
Duration

This corporation shall exist perpetually.

ARTICLE III






