**ARTICLES OF DISSOLUTION
OF

Pursuant to the provisions of Section 607.1403 of the Florida Business Corporation Act, the undersigned corporation adopts the following Articles of Dissolution for the purpose of dissolving **International Drive Property Investments, Inc.**, a corporation organized under the laws of the State of Florida (the "Corporation"):

1. The name of the Corporation is **INTERNATIONAL DRIVE PROPERTY INVESTMENTS, INC.**
2. The Articles of Incorporation of the Corporation were filed on April 22, 2005, under document number P05000059709.
3. The dissolution of the Corporation was authorized by the Shareholders of the Corporation by written consent dated as of December 31, 2006.
