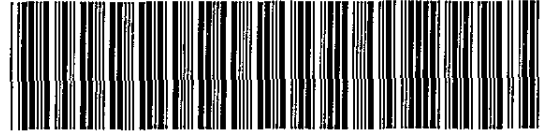

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is Via Cleaning Services, Inc.

ARTICLE II

The existence of the Corporation shall begin on April 19, 2005.

ARTICLE III

The street address of the principal office of the Corporation is 7952 Plantation Lakes Drive, Port St. Lucie, Florida 34986.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 10,000, par value \$1.00 per share, all of which shall be Common Shares. 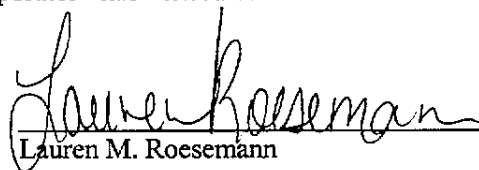

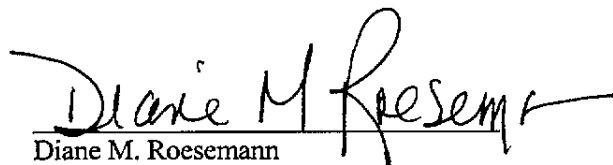
