

ARTICLE X - INDEMNIFICATION

ARTICLE XI - AMENDMENT

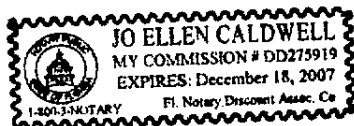


