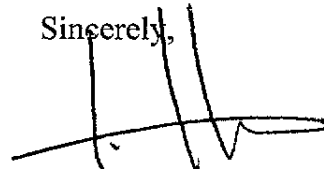

We, RONALD H. BURNETT and LINDA K. BURNETT, being of legal age

hereby authorize the formation of a corporation under the laws of the State of Florida.

ARTICLE I.

The name of this corporation shall be RON BURNETT STUMP GRINDING, INC.

This corporation shall exist perpetually unless sooner dissolved according to law.

ARTICLE III.

GENERAL NATURE OF BUSINESS

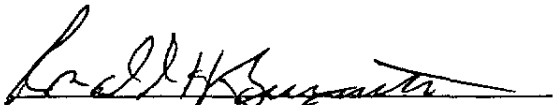
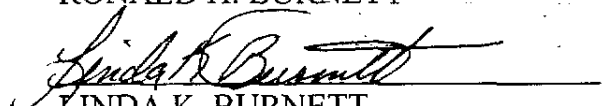

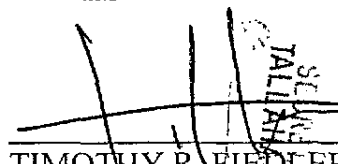
