The undersigned does hereby certify his intention to form a corporation under and by virtue of the laws of the State of Florids, and further certifies that:

> ARTICLE I NAME

ARTICLE III NATURE OF BUSINESS

The general nature of the business or businesses to be transacted under these Articles of incorporation shall be:

To own and operate an automobile repair and service business, a vehicle transport business and to engage such activities or businesses permitted under the laws of the United States and of the State of Florida and to carry out said purposes in any state, territory, district, or possession of the United States, or in any foreign country, to the extent that these purposes are not forbidden by the law of the state, territory, district, or possession of the United States, or by the foreign country.

ARTICLE IV AUTHORIZED SHARES

- A. Number. The aggregate number of shares that the corporation shall have the authority to issue is Ten Thousand (10,000) shares of Capital Stock with a par value of One (\$1.00) Dollar per share.
- B. Initial Issue. One Thousand (1,000) shares of the Capital Stock of the corporation shall be issued for cash at a par value of One (\$1.00) Dollar per share.
- C. Stated Capital. The sum of the par value of all shares of Capital Stock of the corporation that have been issued shall be the stated capital of the corporation at any particular time.
