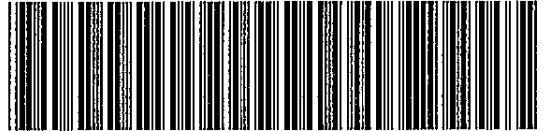

OF

ARTICLE I

The name of this corporation is WIL-LEE ENTERPRISES, INC.





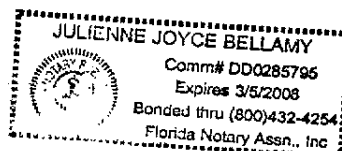
