

ARTICLES OF DISSOLUTION
OF

Pursuant to the provisions of Sections 607.1402 and 607.1403 of the Florida Business Corporation Act, TINKIN, INC., a Florida corporation (the "Corporation"), hereby files the following Articles of Dissolution for the purpose of dissolving the Corporation:

1. The name of the Corporation is: TINKIN, INC. The Document Number of the Corporation is P05000060491. The filing date of the Articles of Incorporation of the Corporation was April 25, 2005.
2. The dissolution of the Corporation was authorized by the Shareholders and the Directors of the Corporation by unanimous written consent dated as of May 1, 2006. The number of votes cast for dissolution was sufficient for approval.
