ARTICLES OF INCORPORATION OF SUNAIR COMMUNICATIONS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I **NAME**

The name of the corporation is SUNAIR COMMUNICATIONS, INC. (the "Corporation").
