




Enclosed please find a 2006 For Profit Corporation Reinstatement for Kevin Scribner Construction, Inc. We recently learned that on September 15, 2006 an Administrative Dissolution for Annual Report was processed on this company.

The original document was mailed April 28, 2006 with check #1601 for \$150. It cleared the bank on May 18, 2006. Per a phone conversation with the Department of Corporations, it is our understanding that a letter was sent in May asking for a FEI Number that was never received. Which resulted in the action on September 15th.
