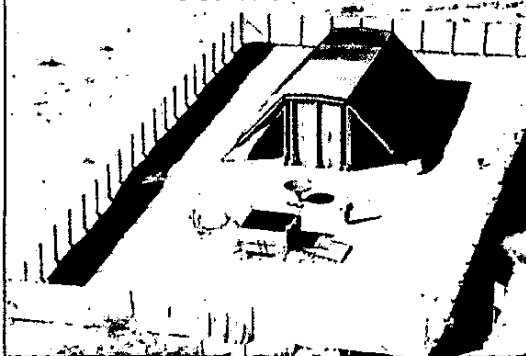

Enclosed is the corrected copy of the 2006 Annual Filing Form. We regret that the second copy sent neglected to have the FIC number written on it. For such a minor error an additional charge of \$391.25 is staggering.

When we first mailed the form we downloaded it from the Internet and mailed it with our check complete as required and prior to the cut off date. We received a copy of a blank form with our check saying the form was needed. Checking our records we had a copy of the original form sent in however the secretary failed to complete the FIC box on the form copy when it was mailed back in.


We attempted to comply with the filing procedures and due to errors of the original form sent not being kept with the check at the opening and then the error the second time on our part of the EIC number not being listed the report, while submitted original on time was not completed due to administrative error.

This is a new company with it's first such filing. We have operated the past year with major deficient and while we are trying to get this Native American owned and operated company operational the expenses of doing so has been too much. For last year and this year we have made no profit and if this continues we cannot.

To pay this additional fee of \$391.25 would be a deathblow to Flying Eagle Promotions at this time. We ask that consideration and forgiveness be allowed to allow our attempt to do things right be honored and that the late fee be waived. If this cannot be done then we have no choice but to dissolve the company and perhaps try again some other time, we just do not have the funds.

Any consideration you can give would be most appreciated.

What Happens Next?

If the review indicates that additional information or changes are necessary, your case will be assigned to an Exempt Organization Specialist in Cincinnati who will call or write you. We assign cases in the order we receive them.

If the additional information indicates that you meet one of the public support tests, you will receive a letter stating that you are a publicly supported organization. If the public support tests are not met, we will send you a letter re-classifying you as a private foundation. That letter will tell you why we believe you do not meet the public support tests, and will include a complete explanation of your appeal rights.

How long will this process take?

Normally, you may expect to hear from us within 120 days. If you do not, you may call our toll free number between the hours of 8 a.m. and 6:30 p.m. Eastern Time. Please have your identification numbers available so that we can identify your case. If you would rather write than call, please include a copy of this notice with your correspondence.
