In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is **LYNDYLAN ENTERPRISES, INC.**

ARTICLE II

The existence of the Corporation shall begin on April 20, 2005.

ARTICLE III

The street address of the principal office of the Corporation is 925 Woodbridge Court, Safety Harbor, Florida 34695.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 500, no par value, all of which shall be Common Shares. 
