**ARTICLES OF INCORPORATION**  
**OF**  
**SOUTHERN CONSTRUCTION BUILDING CONTRACTORS, INCORPORATED**

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I**

**NAME AND ADDRESS**

The name of the corporation shall be Southern Construction Building Contractors, Inc., principal office, if known, or the mailing address of the corporation is 3130 W. Fairfield Drive, Pensacola, Florida 32505.

**ARTICLE II**

**DURATION**

The duration of the Corporation is perpetual.

**ARTICLE III**

**PURPOSE**

The general purposes for which the corporation is organized are as follows:

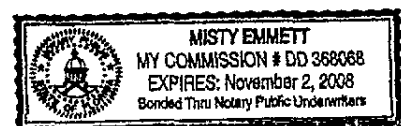
