ARTICLES OF INCORPORATION
OF
LSNP, INC.

STATE OF FLORIDA
TALLAHASSEE, FLORIDA

ARTICLE I - NAME

The name of the corporation shall be LSNP, Inc. (hereinafter, the "Corporation" or the "Company").

ARTICLE II - PURPOSE

The purpose for which the Corporation is organized is to engage in the conduct of any and all lawful activity or business.

ARTICLE III - PRINCIPAL OFFICE AND MAILING ADDRESS

The initial principal office and mailing address of the Company shall be 2900 - 72nd Street North, St. Petersburg, Florida 33710.

ARTICLE IV - CAPITAL STOCK

The authorized capital stock of the Corporation shall be 1,000,000 shares, par value \$.01 per share, designated as common stock.
