The undersigned, acting as incorporator of this Corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME OF CORPORATION

The name of this Corporation shall be Carter-Vineland Management, Inc.

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The principal office of this Corporation shall be located at 3333 S. Orange Avenue, Suite 200, Orlando, Florida 32806-8500, which shall also be the mailing address of the Corporation.

ARTICLE III - CAPITAL STOCK


This Corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.


ARTICLE IX - DATE OF EXISTENCE
