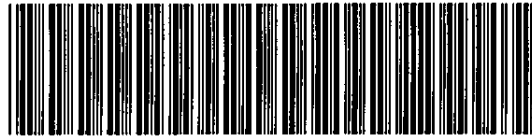

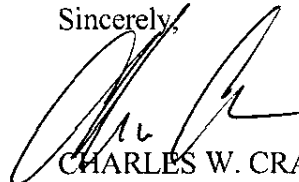

1. Article I of the Articles of Incorporation is amended to read as follows:

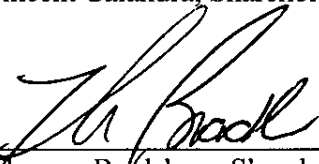
The name of this Corporation shall be **Calandra Enterprises, Inc.**
