# ARTICLES OF INCORPORATION OF ADAM SPRAGUE CARPENTRY, INC.

## ARTICLE I - NAME

The name of this corporation ADAM SPRAGUE CARPENTRY, INC.

#### **ARTICLE II - PURPOSE**

This corporation is organized for the following purposes:

- 1. To operate a business related to Residential/New Home Construction;
- 2. To transact any and all lawful business.

#### **ARTICLE III - POWERS**
