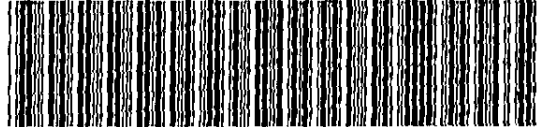

Article I
Identification




