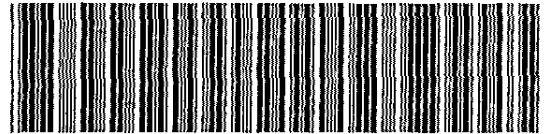

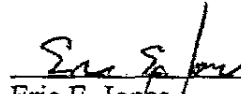

The undersigned, acting as the incorporator under the Florida Business Corporation Act, Chapter 607 Florida Statutes (F.S.), adopts the following Articles of Incorporation for such corporation:

1. The name of the corporation shall be **Eric E. Jones, CRNA, P.A.**
2. The street address of the principal office of the corporation is:

4. The purpose of the corporation is to render professional nursing anesthesia services through nurse anesthetists licensed to practice medicine in the State of Florida.
5. The corporation is a professional corporation and elects to be governed by the provisions of the Florida Professional Service Corporation and Limited Liability Company Act, Chapter 621 F.S.
6. The corporation is authorized to issue One Thousand (1,000) shares of common stock, having no par value. These shares collectively shall have unlimited voting rights and full and equal rights to share in the profits of the corporation and its net assets upon dissolution.

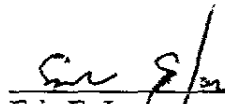
9. The corporation is for profit.
10. To the fullest extent permitted by Chapter 607.0831 of the Florida Business Corporation Act (the "Act"), as in effect on the date hereof and as hereafter amended from time to time, the liability of a director to the corporation or its shareholders for monetary damages for any action taken, or any failure to take any action, as a director shall be eliminated, except for: (i) the amount of financial benefit received by a director to which he is not entitled; (ii) an intentional infliction of harm on the corporation or the shareholders; (iii) a circumstance under which the liability provisions of Chapter 607.0834 F.S. are applicable; (iv) a circumstance under which the professional liability provisions of Chapter 621.07 F.S. are applicable; or (v) an intentional violation of criminal law.
11. With respect to claims or liabilities arising out of service as a director or officer of the corporation, the corporation shall indemnify and advance expenses to each present and future director and officer (and his or her estate, heirs and personal representatives) to the fullest extent allowed by Chapter 607.0850 of the Act and the laws of the State of Florida, both as now in effect and as hereafter adopted or amended, provided the requirements of the Act are met.
