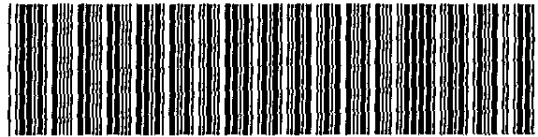

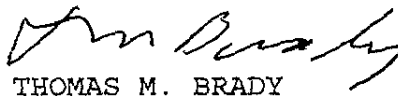

ARTICLE ONE - NAME

The name of the corporation is JW'S INTRACOASTAL GRILL, INC.

ARTICLE TWO - DURATION

This corporation shall have perpetual existence.

ARTICLE THREE - PURPOSE

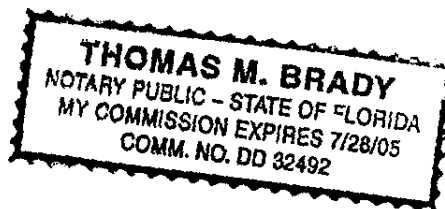
