ARTICLE I - NAME AND BUSINESS ADDRESS

The name of this Corporation is BLOOD MONEY PUBLISHING, INC. Its principal office address and business mailing address is 420 N.W. 104TH Terrace, Miami, FL 33150.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

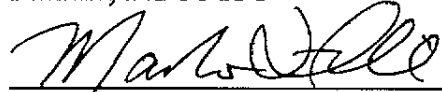
