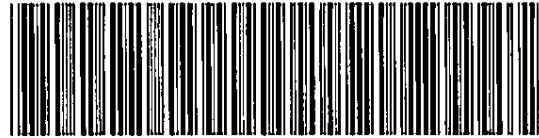

- 2) Articles of Correction Form.


As stated in your letter, the department received our check for \$35.00 Please apply it to one of the attached filing transactions.
