CHANGE OF REGISTERED AGENT/REGISTERED OFFICE/PRINCIPAL OFFICE:

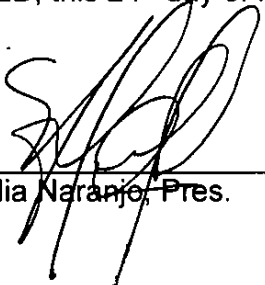
Yumidia Naranjo is hereby deleted as the Registered Agent of the corporation.
