ARTICLES OF INCORPORATION

OF

KEISER I-4, INC.

ARTICLE I

The name of the corporation is KEISER I-4, INC. The principal business address or mailing address of the corporation is: 1900 W. Commercial Boulevard, Suite 180, Fort Lauderdale, Florida 33309.

ARTICLEII

The corporation shall have perpetual existence.


