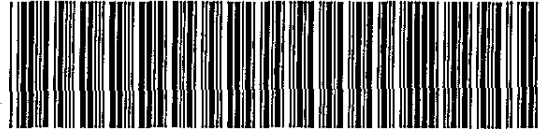

OF

ARTICLE I: NAME

The name of the corporation is: Fleetcraft America, Inc.

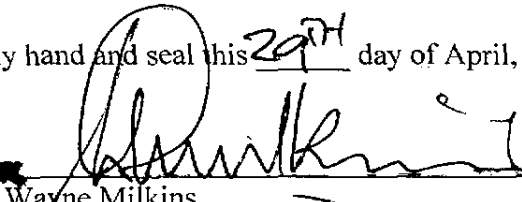

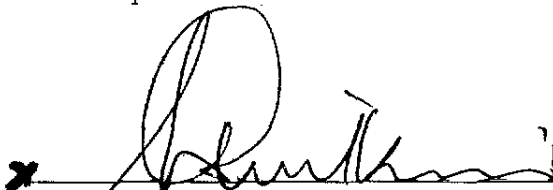
