**ARTICLES OF INCORPORATION
OF
SPACE COAST DOOR COMPONENTS, INC.**

In compliance with the requirements of Chapter 607, Florida Statutes, the Florida Business Corporation Act ("Act"), the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I - NAME

The name of the corporation ("Corporation") is: SPACE COAST DOOR COMPONENTS, INC.

ARTICLE II - PRINCIPAL OFFICE

The principal office and mailing address of this Corporation is: 1462 Rila Street, SE, Palm Bay, Florida 32909.

ARTICLE III - PURPOSE

The purpose for which the Corporation is organized is to engage in any activity allowed by the Act or under the laws of the State of Florida and the United States.
