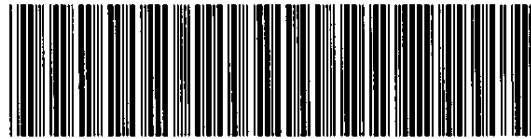



Dissolution of the Corporation was authorized on May 8, 2012..


**ARTICLE VII – ADOPTION OF DISSOLUTION**
