The undersigned hereby certifies that he and the other stockholders have associated for the purpose of becoming a corporation under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of companies for profit and hereby adopt the following Articles of Organization for such corporation:

ARTICLE I

NAME AND PRINCIPAL OFFICE
