#### ARTICLES OF INCORPORATION OF

# **H&H Sign Contractors, Inc.**

The undersigned incorporators of these Articles of **H&H Sign Contractors**, **Inc.**, each a natural person competent to contract, associate themselves together to form a corporation under the laws of the State of Florida.

**ARTICLE I** 

NAME: The name of this corporation H&H Sign Contractors, Inc.

**ARTICLE II** 

CORPORATE PURPOSES: The corporate purposes are:

To engage in any lawful act or activity for which corporations may be organized under the laws of the State of Florida. To operate as a manufacturer, installer and provider of architectural signs and related products and services. To market, sell, and provide signs, frames, and similar products and to own and/or operate equipment, fixtures, data bases, lists and other assets necessary in carrying on the business of providing and selling such products and services. The corporation's products and services are sold primarily to builders, constructors and building owners and operators, as well as to government agencies, societies, clubs, corporations or other types of business organizations.

To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise acquire or dispose of the shares of the capital stock of, or any bonds, securities, or other evidences of indebtedness created by any other corporation of the State of Florida, or any other State or Government, and while owner of such stock or instrument to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.

To purchase, manufacture, or otherwise to acquire, and to own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, and to invest in, trade, deal in and with goods, wares, merchandise, real and personal property, and services of every class, kind and description; except that it is not to conduct a banking, safe deposit, trust, insurance surety, express, railroad, canal, telegraph, telephone, cemetery, professional engineering and survey company, a building and loan association, fraternal benefit society or exposition.

#### ARTICLE III

CAPITAL STOCK: The shares of stock of this corporation shall consist of only one class. The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time is One Thousand (1,000) shares of Common Stock having \$1.00 par value.
