Articles of Incorporation

Articles of Incorporation of OBJECTIVE TRADING GROUP, Inc.

The undersigned person, acting as incorporator for the purpose of forming a stock business corporation under the laws of the State of Florida, adopts the following Articles of Incorporation:

Article 1. The name of the corporation is OBJECTIVE TRADING GROUP, Inc.

This Corporation reserves the additional right to register and do business in all any and/or all countries approved by the Government of the United States of America for trade and international commerce,

Article 3. The duration of this corporation shall be perpetual.

Article 4. The total amount of initial capitalization of this corporation is \$1,000.00.

Article 5. The total number of shares of common capital stock that this corporation is authorized to issue is 100.




