#### ARTICLES OF INCORPORATION

OF

## PURE COMFORT A/C, INC.

The undersigned, incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

#### ARTICLES I: NAME OF THE CORPORATION

The name of the corporation is PURE COMFORT A/C, INC. hereinafter referred to as the "Corporation".
