To Whom It May Concern:

I am writing this evening because I just got through to the IRS 800 Help line and finally got to speak with a representative whom was kind enough to research whether our corporate filing (1120S) request for Another Corporation had been received and approved.

I was told that the corporate filing was not automatic and that it will need approval before it becomes an active corporation. I just spoke with representative #81090 (I believe) and she informed me that the application had just been approved and took 'some time' before showing in the system as approved.

Based on the information that I was given about the approval process I was awaiting word from the IRS as to the application's approval. I assumed that if the application was not approved that there would be no corporation and we would have to go through a re-submission process that would push the actual date of the corporate filing into 2006.

Upon hearing that the application had been approved I prepared to print out the Annual Reporting form that had been previously prepared in anticipation of hearing from the IRS and was mortified when, much to my surprise, I saw at the top of the form that the deadline for filing was May 1, 2006. I had it in my mind as May 31.

I logged into the website, tried to find relevant information on the website and decided to contact the 800 number listed in the contact us section. The first menu item I heard was, "please enter your credit card information". I do not have any funds in the corporate account yet so I was hesitant to enter the account information. I hung up and decided to send an email instead.

We applied for the corporation based on the advice of a colleague. We had no need for the corporation during 2005 but wanted the process to be underway. We have tentative plans for using the corporation later in 2006. We planned to seek out advice from a tax professional and/or accountant prior to commencing business.

I sincerely apologize for any inconvenience this may have caused. Given my interpretation of the IRS approval process and my inherent misinterpretation of the information presented, I feel compelled to ask for amnesty for any imposed fines for late filing and ask for understanding and forgiveness for missing the deadline for filing of the Annual Report.
