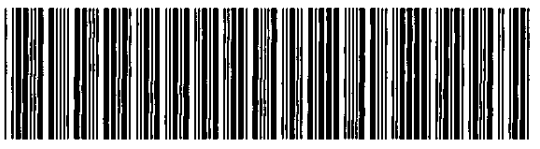

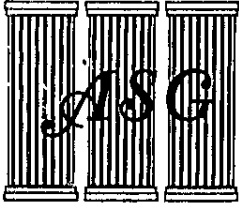



The name of the corporation shall be MAUREEN M. RICHARDS, ARNP, P.A.

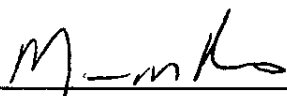
3. Article II of the corporation's Articles of Incorporation are hereby amended to state as follows:
