ARTICLES OF INCORPORATION OF

ARTICLE I - NAME AND ADDRESS: The name of this corporation shall be TAYLOR & TURNER PEST AND TERMITE CONTROL, INC., with its mailing address being 2520 N. Dixie Highway, Wilton Manors FL 33305, and its principal address being 2520 N. Dixie Highway, Wilton Manors FL 33305.

ARTICLE II - NATURE OF BUSINESS: This corporation may engage in any activity or business for which corporations may be incorporated under Chapter 607 of the Florida Statutes.
